RELEASE OF MORTGAGE

The undersigned, Schuler Equipment Company, Inc., a Delaware corporation, for One Dollar (\$1.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby release, cancel, annul and discharge that certain mortgage and the lien thereof wherein C. P. Lifsey and A. A. Lifsey are mortgagees and Dixie Lime and Manufacturing Company is mortgagor, dated April 29, 1954, securing an original principal amount of Twenty-Six Thousand Three Hundred Forty-Two and 49/100 (\$26,342.49) Dollars, and recorded in the office of the Probate Judge of Shelby County, Alabama, in Mortgage Volume 232 at Page 373, which said mortgage was set over and assigned to Schuler Equipment Company, Inc., by written assignment dated August 9, 1954, and recorded in Volume 167 at Page 481 in the office of the Judge of Probate of Shelby County, Alabama. 
