for and in consideration of the sum of ~~One~~ ⁰⁰ ~~100~~ Dollars (\$.....), to in hand paid by Alabama Power Company, a corporation, the receipt of which is hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to implant, install and maintain anchor.... of wood or other material at One point.... on the property hereinafter described, and to construct, extend and maintain guy wires from said anchor.... to structures now erected or hereafter to be erected on said land. Said anchor....and guy wires to be located on and across lands of the undersigned in the County of Shelby, State of Alabama:

The lands on which said anchor.... and guy wires are to be implanted or installed are described as follows:
A lot in the SW $\frac{1}{4}$ of Section 28, Tp. 19, R 2 W beginning at the point where the line separating the McGuire and Crumley lands intersects the SE boundary of Cahaba Valley Road and run NE along said road 31.5 ft; thence run SE perpendicular to said road 210 ft; thence turn 90° right and run 31.5 ft; thence run NW 210 ft. to point of beginning.

TO HAVE AND TO HOLD the same to the said Alabama Power Company, its successors and assigns, forever.
