as joint tenants, with right of survivorship, the following described real estate, situated in

County, Alabama, to-wit:

All of the NW $\frac{1}{4}$  of SW $\frac{1}{4}$  lying Southeast of Pumpkin Swamp road.

All that part of the West 110 yards of the NE $\frac{1}{4}$  of SW $\frac{1}{4}$  lying Southeast of Pumpkin Swamp Road, and all in Section 21 Township 19, Range 1 East, and situated in Shelby County, Alabama.

TO HAVE AND TO HOLD Unto the said Vernon Prickett and wife, Margaret Prickett

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.
