way line of U. S. Highway No. 280 (also known as Ala. Highway 91) and run north 56  
degrees 20 minutes west, along said right of way line 1870 feet to an iron pin to  
the point of beginning of the land herein conveyed, which point of beginning is the  
westmost corner of a lot being conveyed to Otis W. McCall and Ocie L. McCall; thence  
run north, 33 degrees 40 minutes east, 266.40 feet; thence north, 56 degrees 20 minutes
