ROAD RIGHT OF WAY DEED

KNOW ALL MEN BY THESE PRESENTS, that the undersigned Plantation Pipe Line Company, a Delaware Corporation hereinafter referred to as "PLANTATION", for and in consideration of One Dollar (\$1.00) in hand paid by Shelby County, Alabama, the receipt whereof is hereby acknowledged; and the terms and conditions hereinafter set out, does hereby give, grant, bargain, sell and convey, but without warranty, unto Shelby County, a political subdivision of the State of Alabama, hereinafter referred to as the "COUNTY", for road purposes only, with reversion in the event of abandonment, a right of way hereinafter described over and across lands of Grantor in Shelby County, Alabama, which right of way shall be 50 feet in width, same being more particularly described as follows:

Beginning at the N. E. corner of the S. E. 1/4 of S. E. 1/4 S 15 T 20S R 3W and being on the dividing line between Sections 14 and 15; run thence S 89° 51' 30" W along property line dividing property of grantor and F. F. Mullins 297.30 feet to a point of beginning. From said point of beginning run thence S 17° 24' 30" E 410.93 feet to a point on the North right of way line of the Helena-Pelham public road, said course being the easterly right of way line of the 50 foot road right of way herein conveyed; run thence N 61° 16; 30" W 36.08 feet to a point, run thence N 65° 08; 30" W 33.78 feet to a point, said course being along the North right of way line of said Helena-Pelham public road; thence run N 17° 24' 30" W 377.76 feet to a point on the property line dividing lands of Grantor and F. F. Mullins, said course being the westerly right of way line of the road right of way herein granted; run thence along said property line N 89° 51' 30" E; 52.36 feet to the point of beginning.

All as more particularly described on Plantation's drawing, No. D-WD-11-58, dated March 5, 1958, which is attached to and made a part of this instrument.

In further consideration of this grant the COUNTY through its Board of Revenue and Control hereby agrees to construct this road and have same hard surfaced, both without cost to PLANTATION, and agrees that said hard surfacing shall be completed as soon as possible, but not later than December 31, 1959.

I, S. V. Kane, Secretary of Plantation Pipe Line Company, do hereby certify that the following resolution was passed at a meeting of the Board of Directors held on March 11, 1958, duly called and at which there was a quorum present and voting:

RESOLVED, That the President be and he hereby is authorized to transfer to Shelby County, Alabama, the following parcel of land at Helena station for the use by the public as a public road, street, highway or thoroughfare:

Approximately .45 acre comprising a road right-of-way 50 feet in width and 392.7 feet in length. The right-of-way lies in the SE½ of the SE½, Sec. 15, T20S, R3W, Shelby County, Alabama.

This right-of-way dedication will provide for a public road leading off of the Helena-Pelham road and proceeding in a northerly direction 392.7 feet to the north line of Plantation Pipe Line Company's property. The property, comprising a total of 115 acres, as to which this road deed is given, was acquired by Plantation from Standard Oil Company (Kentucky) by deed dated January 13, 1942, of record at deed book 113, page 48, in the records of the Judge of Probate, Shelby County, Alabama.
