TO HAVE AND TO HOLD to the said Virgil Harris & wife, Janay Harris heirs and assigns forever.

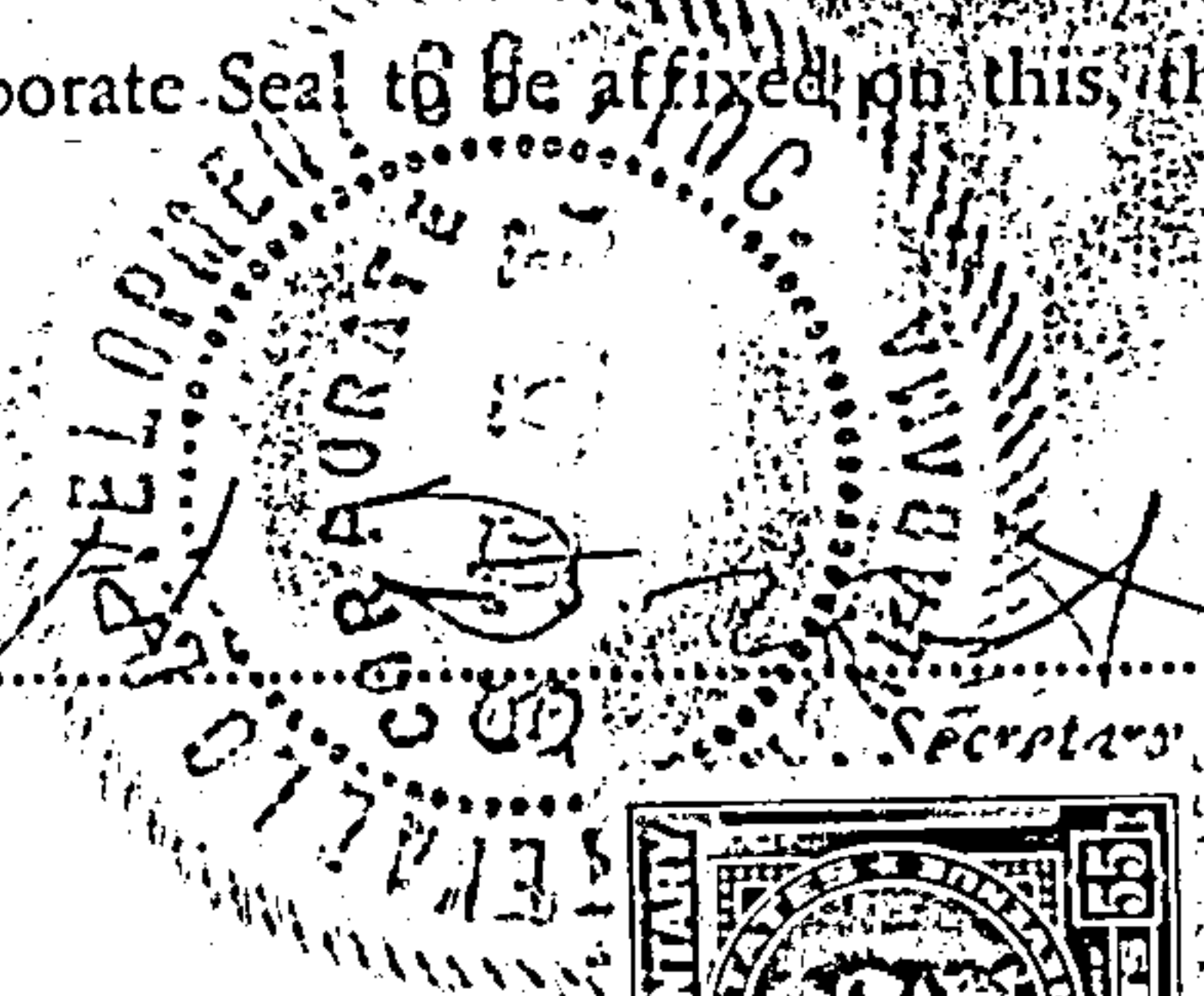

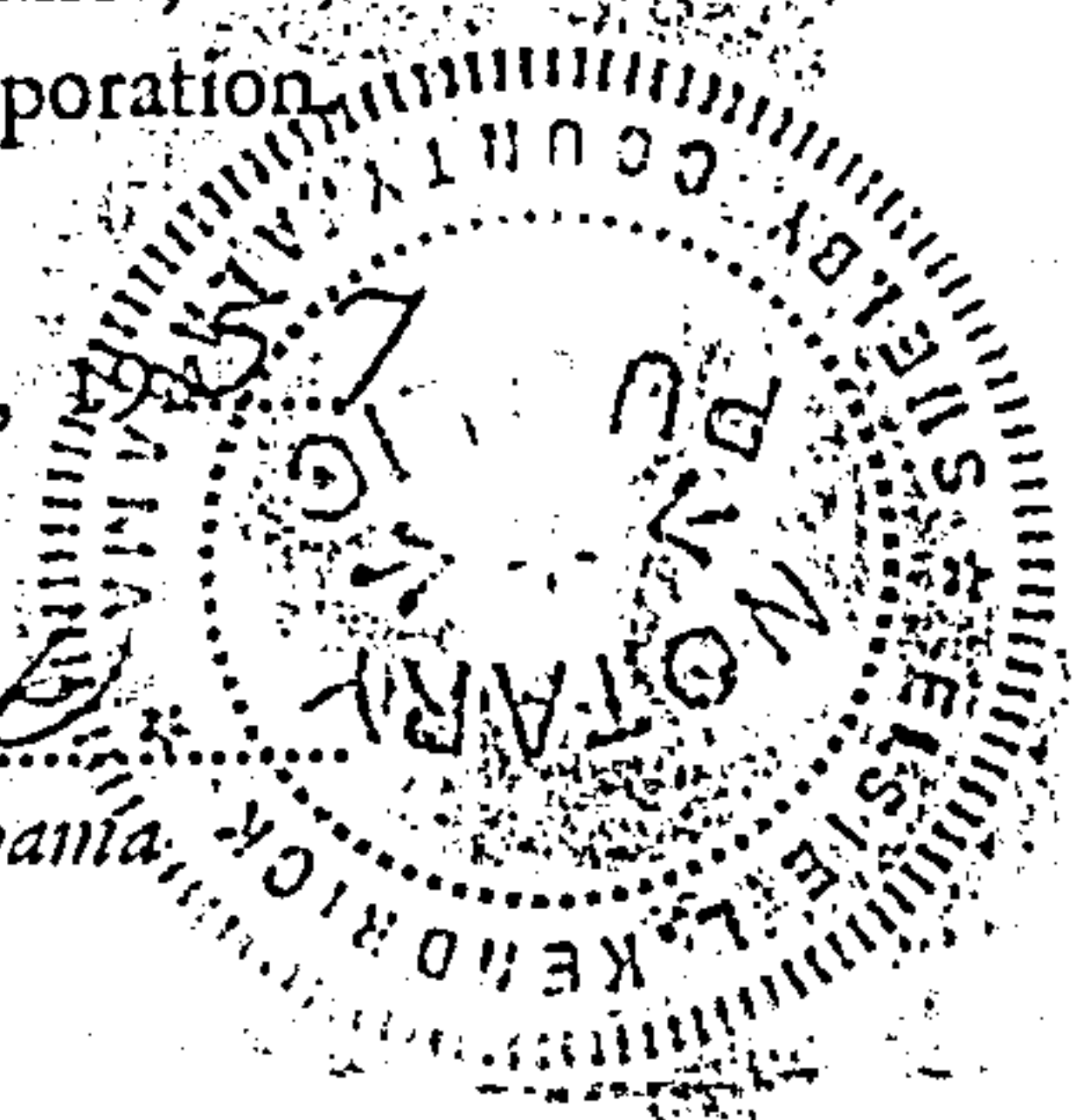
