the receipt whereof is acknowledged we the said Oscar Bernard Garrett and Betty Willis Garrett

do grant, bargain, sell and convey unto the said Nancy Aileen Garrett and Wanda Gail Garrett

the following described real estate, to-wit: A lot in Calera, Alabama, on Central Avenue, and described as being the lot North of the B. Adkins lot; and running North 75 feet from the NW corner of said Adkins lot along the east side of Central Avenue; thence East 150 feet to a lot known as the Doak lot; thence south along the west side of the Doak lot 75 feet; thence west along the north line of the B. Adkins lot 150 feet to point of beginning, being a lot fronting 75 feet on Central Avenue and running back along the North line of B. Adkins lot 150 feet.

The above described lot being the lot conveyed by J.D. Hardy & wife to the parents of the said Cora B. Hardy, to the Cumberland Presbyterian Church on 16th day of April, 1885, on the condition that if the said lot should ever cease to be used for church purposes that the same should revert to the original owners.
