TO HAVE AND TO HOLD, To the said L. C. and Nell J. Parnell, their heirs and assigns forever.

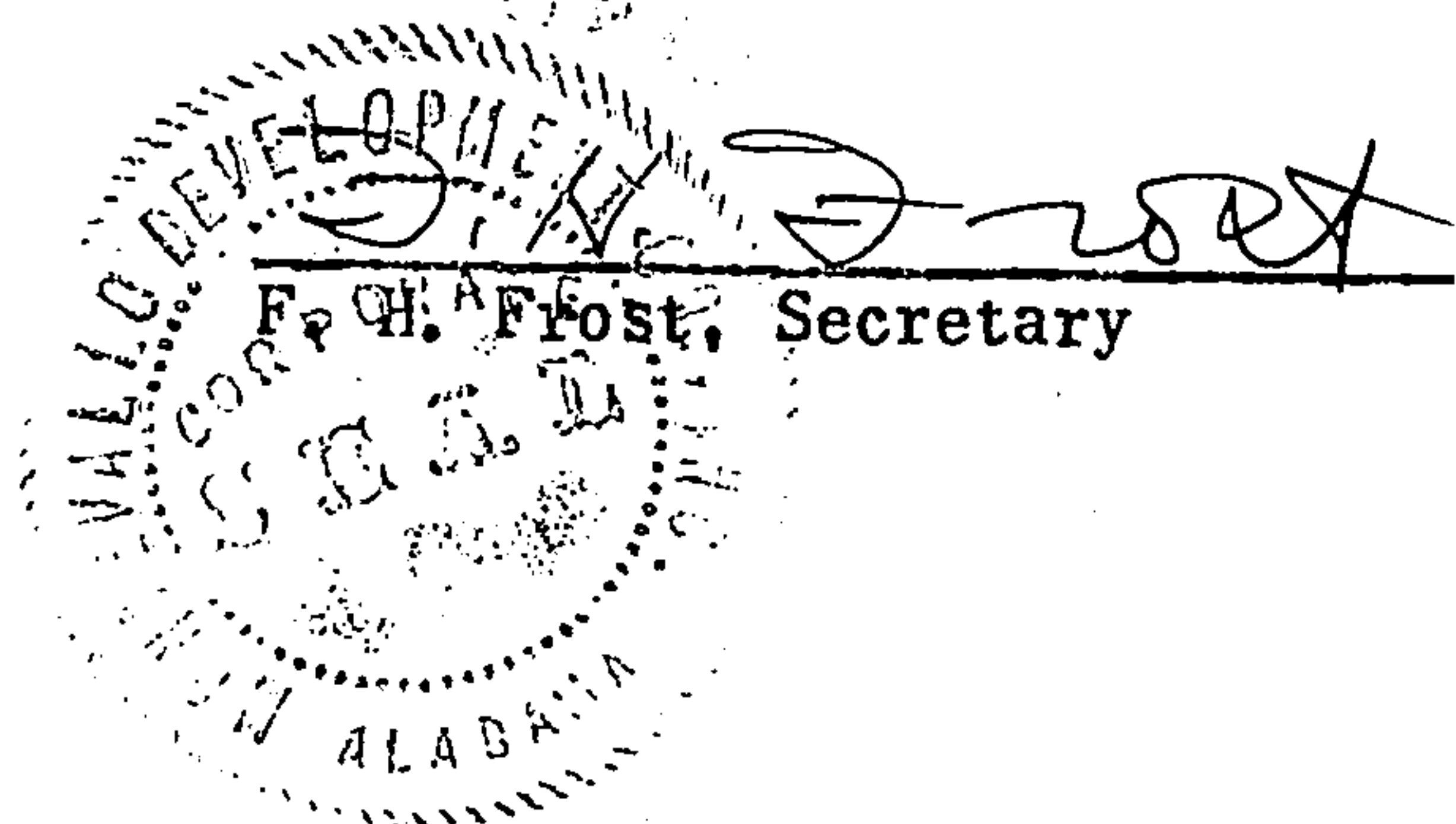

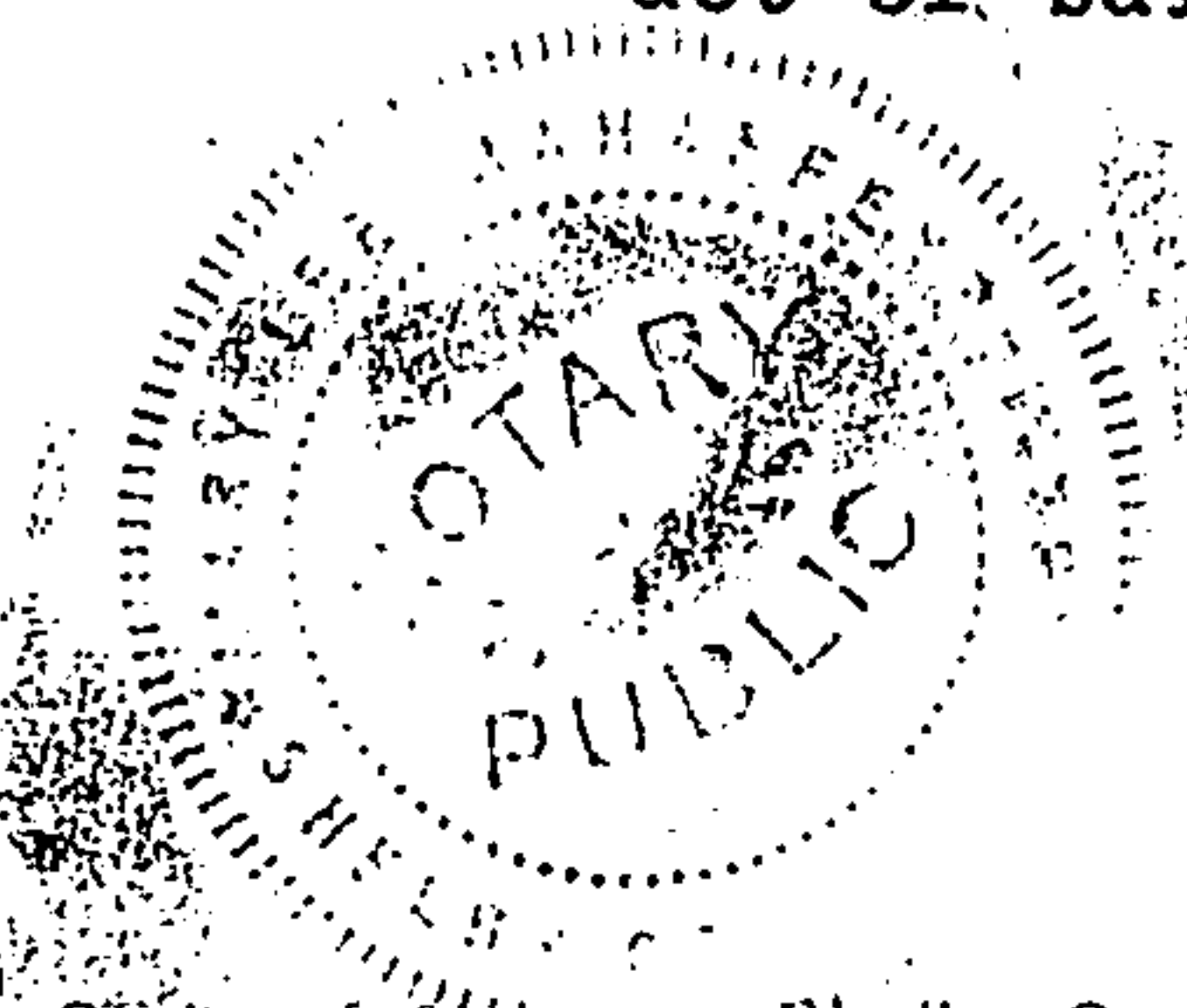
