AFFIDAVIT

BEFORE ME, Charles P. Walker, the undersigned authority, in and for said County, in said State, personally appeared Mary Cost, who after being by me first duly sworn to speak the truth, deposes and says: My name is Mary Cost. I am one and the same person as Mary E. Cost. I am 79 years of age. I am a sister of Walter M. Cost, Henry E. Cost, Cordra A. Cost and Russell P. Cost. My said brothers and sisters and I are the sole and surviving heirs at law of J. H. Cost, deceased. Walter M. Cost was an unmarried man and he died without a will on March 6, 1949. Henry E. Cost was an unmarried man and he died without leaving a will on December 20, 1949. Cordra A. Cost was an unmarried woman and she died without leaving a will on November 9<sup>th</sup>, 1956. R. P. Cost and I were, and are the sole surviving heirs at law and next of kin of Walter M. Cost, Henry E. Cost and Cordra A. Cost. On October 22, 1945 and on November 29, 1948, Walter M. Cost; Henry E. Cost, being one and the same person as H. E. Cost; R. P. Cost, being one and the same person as Russell P. Cost; and Cordra A. Cost, being one and the same person as Cordra Cost; and I, the said Mary E. Cost, were all unmarried, and were the owners of the lands which we conveyed to A. H. Lee and wife, Lucille G. Lee on said dates, as shown by deeds recorded in Deed Book 123, Page 103, and Deed Book 140, Page 203 in the Office of the Judge of Probate of Shelby County, Alabama. On December 15, 1952, Cordra A. Cost, R. P. Cost and I, the said Mary E. Cost, were all unmarried, and were the owners of the lands which we conveyed to A. H. Lee and his heirs, on said date, as shown by deed recorded in Deed Book 157, Page 103, in the Office of the Judge of Probate of Shelby County, Alabama.
