

Know all men by these presents, That in consideration of ONE DOLLAR (\$1.00) DOLLARS

the receipt whereof is acknowledged we the said A. H. Lee and wife, Lucille G. Lee
do grant, bargain, sell and convey unto the said Robert G. Butler and wife, Frances H. Butler

the following described real estate situated in Shelby County, Alabama, to-wit:
For a point of beginning, commence at the Southwest corner of Section 14,
Township 21 South, Range 3 West Shelby County, Alabama, run thence South
87 degrees 30 minutes East along the south line of said Section 14, a distance
of 604.00 feet to the point of beginning; From said point of beginning,
thence turn an angle of 91 degrees 00 minutes to the left and run
North 1 degree 30 minutes East a distance of 295.00 feet; thence turn
an angle of 91 degrees 00 minutes to the right and run south 87 degrees
30 minutes east, 623.40 feet to the west right of way line of the Monte-
vallo-Siluria Highway, thence turn an angle of 59 degrees 38 minutes to
the right and run south 32 degrees 52 minutes east along the west right of
way line of said Highway a distance of 111.20 feet; thence turn an angle
of 119 degrees 30 minutes to the right and run north 86 degrees 38 minutes
west a distance of 284.5 feet; thence turn an angle of 96 degrees 32
minutes to the left and run south 3 degrees 10 minutes east, a distance of
