KNOW ALL MEN BY THESE PRESENTS that F. F. Mullins, whose wife, Ethel L. Mullins, joins with him in execution of this dedication of rights of way hereinafter described, do hereby dedicate TO THE PUBLIC, for use as a public road or street, the following property, namely:

No. 1: A 50 foot right of way, the centerline of which is described as follows: From the Southeast corner of the N $\frac{1}{2}$ of SE $\frac{1}{4}$, Section 15, Township 20 South, Range 3 West, run West along the South line of said N $\frac{1}{2}$ of SE $\frac{1}{4}$ for 218.94 feet, thence right 78 degrees 20 minutes for 289.02 feet to the point of beginning, thence left 79 degrees 56 minutes for 989 feet, more or less, to Rolling Mill Road.

No. 2: A 50 foot right of way, the centerline of which is described as follows: From the Southeast corner of the N $\frac{1}{2}$ of SE $\frac{1}{4}$, Section 15, Township 20 South, Range 3 West, run West along the South line of the N $\frac{1}{2}$ of SE $\frac{1}{4}$ for 871.9 feet, thence right 90 degrees 20 minutes for 308.16 feet to the point of beginning, thence right 90 degrees for 420 feet, more or less, to the centerline of a proposed county road.

The consideration for the execution of the dedication of rights of way is that said F. F. Mullins has sold to James F. Shackelford certain lands, and it is desired that there be a right of way for a public road or street so that access may be had to said land and for the use of the public generally.
