KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One (\$1.00) Dollar, and other good and valuable consideration

to the undersigned grantor, MID SOUTH DEVELOPMENT CORPORATION a corporation, in hand paid by Richard Charles Dove and Annie Bell Dove the receipt whereof is acknowledged, the said MID SOUTH DEVELOPMENT CORPORATION

does by these presents, grant, bargain, sell, and convey unto the said Richard Charles Dove and wife, Annie Bell Dove

as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:



Lot Six (6), Block Thirteen (13), Lincoln Park Subdivision, a plat of which is recorded in Map Book

TO HAVE AND TO HOLD said property unto the said Richard Charles Dove and Annie Bell Dove as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.
