Begin at a point where the south line of the SE1/4 of NW1/4 of Section, 34, Township, 19, Range.2, East, intersects with the Westerly line of the right-of-way of the Chancellors Ferry Road, and thence run northwesterly along said Public Road 900 feet to the beginning point; thence continue along said Public Road in a northwesterly direction one hundred (100) feet; thence run in a southwesterly direction and perpendicular to said Public Road one hundred (100) feet; thence run in a southeasterly direction and parallel to said Public Road a distance of one hundred (100) feet; thence run in a northeasterly direction and peppendicular to said Public Road, a distance of one hundred (100) feet to the point of beginning.

Being in the S1/2 of NW1/4 of Section 34, Township, 19, Range. 2. East, Shelby County, Alabama.
