WHEREAS, party of the first part owns and has title to that certain real estate in Shelby County, Alabama, described as follows:

WHEREAS, parties hereto desire to create and dedicate a 22 foot roadway of equal width to party of the second part and to the general public across the west part of the property of the party of the first part, and

WHEREAS, in consideration of the granting of this roadway, party of the second part has agreed to construct a roadway along said land so dedicated;

NOW, THEREFORE, it is hereby agreed as follows: Party of the first part does hereby grant, bargain, sell and assign unto party of the second part and to the general public, an easement for a public roadway described as follows:

Commence at the NW corner of  $E_2^1$  of  $NW_4^1$  of  $NE_4^1$  of  $NE_4^1$ , Section 11, Township 24, Range 12 East and run Southerly along the West boundary of said 5 acre tract to the SW corner thereof; thence Easterly and parallel with the North boundary of said 5 acre tract, 22 feet; thence Northerly and parallel with the West boundary of said 5 acre tract to the North boundary of said 5 acre tract; thence Westerly along the North boundary of said 5 acre tract 22 feet to point of beginning.

Said roadway to extend as shown above from the Montevallo-Jemison Highway to the South boundary of  $SE_{4}^{1}$  of  $SE_{4}^{1}$  of Section 2, Township 24, Range 12 East.

The party of the first part shall fully use and enjoy the aforesaid premises, except as to the rights herein granted; and party of the second part agrees to construct a roadway over said described premises.

TO HAVE AND TO HOLD the said easement, right and right of way unto the party of the second part and to the general public under the conditions as set forth above.
