KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of one dollar, to Paul O. Luck and wife, Clarice Luck and Harry Gordon and wife, Ila Gordon in hand paid by Johnny Spain, the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said Johnny Spain all our right, title, interest and claim in or to the following described real estate, to-wit:

Beginning at a point which is 14 chains south of the quarter section corner between sections 9 and 16 in Township 22, Range 2 West; thence south 6 chains and 13 links to the southwest corner of the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 16 in above township, from which corner stands a red oak 6" in diameter south 36 degrees, east 10.80 links, a red oak 5" in diameter north 84 degrees, 30' west 53 links, continue south from said corner 3 chains to a point; thence east 6 chains 50 links to the west side of the Calera & Birmingham wagon road; thence in a northerly direction along the west side of said road to the L & N R R right of way five & 20/100 chains; thence along said right of way in a northerly direction 4 chains to a point; thence west 7 chains and 29 links to the place of beginning.

The said piece of land is situated in the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  and in the SW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 16 Township 22 Range 2 West, and containing 8.50 acres, all being situated in Shelby County, Alabama.


