I am acquainted with the following land situated in the Town of Calera, Shelby County, Alabama, namely:

The North Half of Lots 6 and 7 and 22 feet off the East side of the South Half of Lot 7, all in Block 10, according to Dunstan's Survey and Map of the Town of Calera, Alabama.

I purchased this land from my brother Walter Glass in 1927 and at that time said Walter Glass was in possession of said property. Walter Glass made me a deed to it on August 25, 1927, which deed is recorded in the Probate Office of Shelby County, Alabama, in Deed Book 75, page 547, but the property was not completely or correctly described in that deed. However, as soon as I purchased the land from said Walter Glass I went into possession of it as above described and have lived in a dwelling house on it continuously to the present time and all the time since I bought it and to the present time I cultivated garden spots on it and also flowers, and I have had said property under fence from the time Ipurchased it down to the present time. From the date of said deed to the present time I have been in the actual, open, notorious, continuous, exclusive, adverse, hostile possession of said property above described, living upon it and cultivating it each and every year as above stated. During all that time no other person, firm, or corporation has been in possession of said property or any portion thereof except myself.

Said property is more particularly described as follows:

Commence at the point of intersection of the South line of Twelfth Avenue according to Dunstan's Map of Calera, Alabama, and the East right of way line of a road lying West of and contiguous to the West line of Lot 6, Block 10 according to said Survey, and from said point of beginning run East along the North line of said Lots 6 and 7, 96 feet to the NW corner of Lot 11, Block 10 according to said Survey; thence South along the West line of Lot 11 and the West line of Lot 8, allin Block 10, according to said Survey, to the SW corner of said Lot 8, which is the SE corner of said Lot 7; thence West along the South line of said Lot 7, 22 feet; thence North and parallel with the East line of said Lot 7, 93 feet, more or less, to the South line of North Half of Lot 7, Block 10 according to said Survey; thence West along the South line of the North Half of said Lot 7 and the North line of the South Half of said Lot 6, 74 feet to the West line of said Lot 6, being also to the East right of way line of said road; thence North along the West line of said Lot 6 93 feet, more or less, to the point of beginning.
