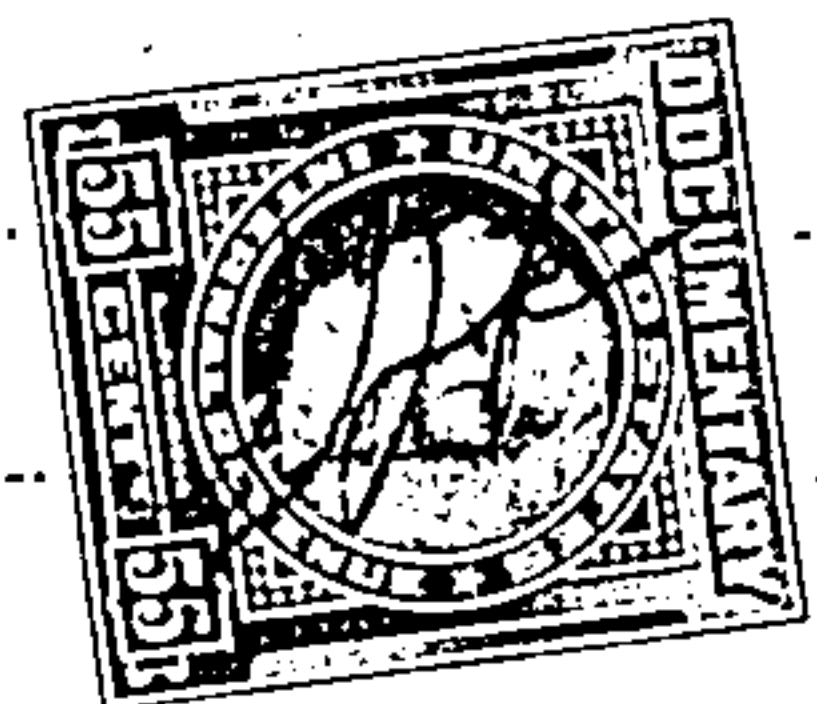

For a point of beginning commence at the southwest corner of the Southwest Quarter of the Northwest Quarter of Section 14, Township 21, South, Range 3 West and run north along the west boundary of said forty acres of land 895.64 feet; thence turn an angle of 90 degrees to the right and run easterly 119.7 feet; thence turn an angle of 63 degrees to the right and run in a southeasterly direction 142.11 feet to the point of beginning of the land herein described; from said point of beginning continue to run in said southeasterly direction 112.89 feet; thence turn an angle of 60 degrees and 43 minutes to the left and run in

an easterly direction 413.5 feet, more or less, to the west
 right of way line of the Siluria-Montevallo Road; thence turn
