POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That T. 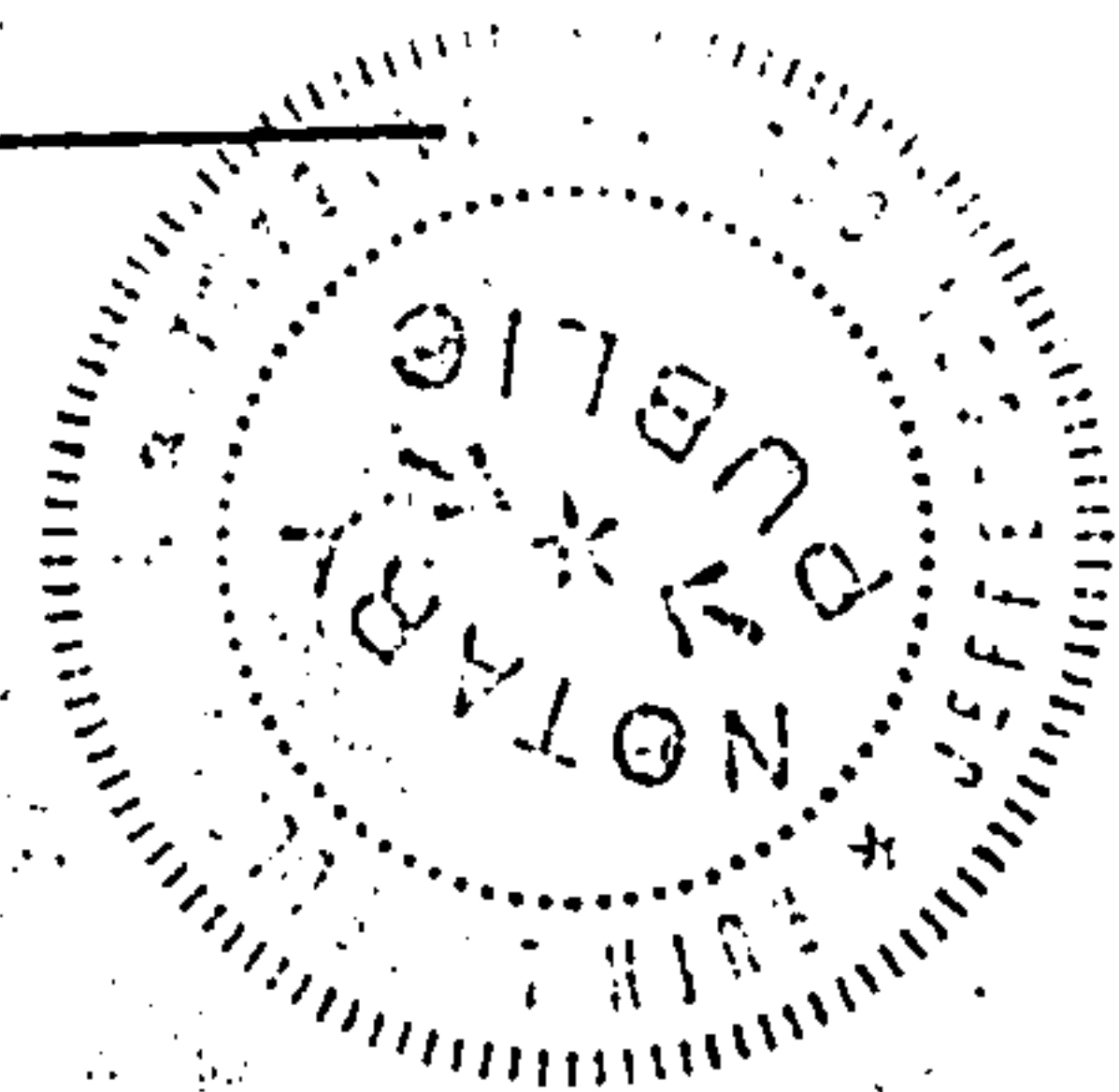
