To give the Government written notice of the commencement of any proceedings to foreclose the mortgage(s) held by the undersigned as afore- . said, by delivering in person or by mailing such notice to the State Director, Farmers Home Administration, United States Department of Agriculture, Montgomery, Alabama, at least ten (10) days prior to the commencement of such action; and the unlersigned does further agree that this agreement shall be irrevocable, that it shall be binding upon the heirs and assigns of the undersigned and that upon any assignment of the mortgage(s) held by the undersigned as aforesaid, the undersigned will endorse, on the face of such mortgage (s) being assigned the following: "ACTUAL NOTICE OF COMENCEMENT OF FORECLOSURE PROCEEDINGS SHALL BE GIVEN TO THE STATE DIRECTOR, FAR: ERS HOME ADMINISTRATION, UNITED STATES DEPART-"MENT OF AGRICULTURE, MONTGOMERY, ALABAMA, IN ACCORDANCE WITH AGREEMENT DATED September 24, 1958, AND RECORDED IN BCO. 196, AT PAGE 350, IN THE FUBLIC RECORDS OF Shelby COUNTY, ALADAM." and will insert in the appropriate blank spaces provided therefor the date of this AGREETENT and the recordation data, whereupon the undersigned will subscribe his or its name thereto.
