AFFIDAVIT OF H. E. ROBERSON

Before me, the undersigned authority, personally appeared H. E. Roberson, who is known to me, and who, being by me first duly sworn, deposes and says as follows:

My name is H. E. Roberson. I am 40 years old, and I have been personally familiar with the possession and ownership of the following described property for the past 30 years, and I have lived in the near vicinity all my life.

Beginning at the Highway post "P.C. 528" on the Columbiana Highway E of Calera, Alabama, thence run N 45 degrees and 45 minutes W. 97.8 feet along E side of 26th Street, thence S 3 degrees, 35 minutes E 301 feet, thence N 87 degrees, 10 minutes, 614.8 feet, thence N 3 degrees, 35 minutes, W 350.6 feet, to Gordon's corner, thence along his line 88 degrees, 10 minutes, W 556 feet, to Highway right-of-way and along said Highway S 46 degrees, 45 minutes, W 89 feet to the beginning point, same being S of and fronting 100 feet on the highway and containing 4.8 acres, more or less, being in SE $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 22, Towhship 22, Range 2 W, being bounded on the W by R. L. Merrell, on the N by Dorothy E. Sinor, on the E by Joel E. Green, and on the S by C. L. Carter.

It has been brought to my attention that Holcombe Mercantile, a corporation, is shown on the public records in the office of the Judge of Probate of Shelby County, Alabama, as holding a mortgage foreclosure deed to said property dated April 17, 1937. I know of my own personal knowledge that neither Holcombe Mercantile Company, a corporation, nor R. L. Holcombe, nor no other person named Holcombe has ever occupied or possessed said property or any part thereof since C. R. Brasher bought said property in 1938 from the State Land Commissioner of Alabama.

C. R. Brasher took possession of all of said property in the year 1938 and has occupied the same (except that lot deeded to Delno Brasher and wife, Glennie Brasher on January 28th, 1956, as described at page 396 of Deed Book 190 in the office of the Judge of Probate of Shelby County, Alabama,) as a homestead from 1938 until the present date. During said period since 1938 I have never heard R. L. Holcombe or anyone question title of C. R. Brasher to said property, the said C. R. Brasher, (and Delno Brasher and wife, Glennie Brasher) to my personal knowledge have been in actual, open, peaceable, notorious, continuous, undisturbed, adverse possession of all the said property since he bought the same and went into possession of the same in 1938 until the present date, claiming the same against the claims of all persons whatsoever.
