Cox and wife Winifred Coxfor and in consideration of the sum of one ⁰⁰/₁₀₀ Dollars(\$ 1 ⁰⁰/₁₀₀) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and ~~towers~~ and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and ~~towers~~ upon, over, under and across the following described lands situated inShelby County, Alabama:Five acres more or less in the NE. corner of the NW 1/4 of the SW 1/4 of Sect. 22, Tp. 20, R 3 W, bound on the north by the property of Lucille Wheeler; on the south by property of G.T. Kirkpatrick; on the east by property of F.E. Cox and on the west by a branch.Right of way limited to relocation of one pole and guy wire and extension of line to the G.T. Kirkpatrick property line.
No trees on the property of grantor are to be cut.Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; ~~and also the right to cut and keep clear all trees~~, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
