Know All Men By These Presents,

That in consideration of Love & Affection & the sum of One & no/100 DOLLARS

to the undersigned grantors Henry Grady and Elizabeth C. Grady

in hand paid by Margaret Grady Jones and husband, Robert C. Jones, Sr.

the receipt whereof is acknowledged we the said Henry Grady and Elizabeth C. Grady

do grant, bargain, sell and convey unto the said Margaret Grady Jones & Robert C. Jones, Sr.

as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

A parcel of land in the $S\frac{1}{2}$ of $SE\frac{1}{4}$ of Section 12, Township 22 South, Range 3 West, more particularly described as follows: Commence at the SE corner of said Section 12, Township 22, South, Range 3 West and run thence Westerly along the south boundary of said Section 12, 1331.5 feet to point of beginning; thence turn an angle of 87 deg. 43' to the right and run thence Northerly and parallel with the East boundary of said Section 12, 1337.1 feet to the North boundary of $SW\frac{1}{4}$ of $SE\frac{1}{4}$ of said Section; thence turn an angle of 87 deg. 18' left and run Westerly along the North boundary of said Quarter Quarter Section 333 feet; thence turn an angle of 92 deg. 42' to the left and run thence Southerly and parallel with the East boundary of said Section, 1339.5 feet to the south boundary of said Section 12, thence turn an angle of 87 deg. 43' left and run Easterly along the south boundary of said Section 12, 333 feet to point of beginning.

ALSO, the right to use as a means of ingress and egress to and from the land hereby conveyed, the present farm road running generally southwesterly across the $S\frac{1}{2}$ of $SE\frac{1}{4}$ Sec. 12, Tp 22 S, Range 3 West which said road intersects the Calera-Montevallo dirt road.

SUBJECT TO existing farm road as described above and the rights of other parties to use said road. ALSO SUBJECT TO right of way of Southern Natural Gas Co and also right of way of Plantation Pipeline Company.

TO HAVE AND TO HOLD Unto the said Margaret Grady Jones & Robert C. Jones, Sr.

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances; except as aforesaid;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
