A parcel of land in the $S_{\frac{1}{2}}^{\frac{1}{2}}$ of $SE_{\frac{1}{4}}^{\frac{1}{2}}$ of Section 12, Township 22 South, Range 3 West, more particularly described as follows: Commence at the SE corner of said Section 12, Township 22, South, Range 3 West and run thence Westerly along the south boundary of said Section 12, 1664.5 feet to point of beginning; thence turn an angle of 87 deg. 13^{1} to the right and run thence Northerly and parallel with the East boundary of said Section 12, 1339.5 feet to the North boundary of $SW_{\frac{1}{4}}^{\frac{1}{4}}$ of $SE_{\frac{1}{4}}^{\frac{1}{4}}$ of said Section; thence turn an angle of 87 deg. 18^{1} left and run Westerly along the North boundary of said Quarter Quarter Section 333 feet; thence turn an angle of 92 deg. 12^{1} to the left and run thence Southerly and parallel with the East boundary of said Section 1311.9 feet to the south boundary of said Section 12; thence turn an angle of 87 deg. 13^{1} left and run Easterly along the south boundary of said Section 12, 333 feet to point of beginning.

Also the right to use as a means of ingress and egress to and from the land hereby conveyed, the present farm road running generally southwesterly across the S_2^1 of SE_4^1 , Sec. 12, Tp 22 S, Range 3 West which said road intersects the Calera-Montevallo dirt road.

SUBJECT TO existing farm road as described above and the rights of other parties to use said road. ALSO SUBJECT TO the public road rights of way and right of way of Plantation Pipeline Company
