KNOW ALL MEN BY THESE PRESENTS, That

IN CONSIDERATION of FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS

GRANT, BARGAIN, SELL AND CONVEY unto the said Shirley Ann Shaner

the following described real estate, situated in Shelby County, Alabama:

Part of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ Section 16, Township 19, Range 1 West, more particularly described as follows: Begin at the NE corner of said Quarter-Quarter section and run West along the Northern boundary of said Quarter-Quarter section 150 feet, thence turn to the left and run in a Southerly direction 440 feet, thence turn to the left and run in an Easterly direction 150 feet to the East boundary of said Quarter-Quarter section, thence North 440 feet to the point of beginning.

TO HAVE AND TO HOLD, To the said Shirley Ann Shaner, her heirs, successors and assigns, forever.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said Shirley Ann Shaner, her

heirs, successors and assigns forever, against the lawful claims of all persons.
