Walker and wife, Pearl Walker, do grant, bargain, sell and convey unto the said Town of Alabaster, Alabaster, Alabama, an easement and right of way of sufficient width (being not overly feet) for the purpose of constructing, reconstructing, maintaining and repairing a sanitary sewer system as provided for by "Improvement Ordinance of November 21, 1958, Number S-2 and Confirmatory Improvement Ordinance of December 12, 1958, Number S-3, the work on same having been designated as Project No. 208, together with all necessary right of access, ingress and egress thereto and therefrom, in, under, over and along the following their successors and assigns described property, with the understanding that the grantors/herein

reserve the right to erect a building over said easement or right of way, with the provision that any repairs done of said sewer line shall be done without injury to said building.

A 12 foot easement running east and west along the north line of a lot being known and identified as L. C. Walker's taxi cab lot situated on the west side of U. S.
