Begin at the southeast corner of the SE 1/4 of the SE 1/4, Section 29, Township 19 South, Range 2 East, and thence run south 87 deg. 30 min. west a distance of 309.2 feet to a point: thence north, 1 deg. west a distance of 157.4 feet to a point: thence north 1 deg. 30 min. west a distance of 228.4 feet to a point; thence north 3 deg. east a distance of 359.0 feet to a point: thence north 3 deg. east a distance of 315 feet to the point of beginning of the lot herein conveyed, which said point is the north-west corner of the Strickland lot: thence continue north 3 degrees east along the easterly line of a gravel road 105 feet; thence turn and angle of 94 deg. 37 min. to the right and run in a southeasterly direction 210 feet: thence turn and angle of 85 degrees 23 minutes to the right and run in a southerly 105 feet to the northeast corner of the Strickland lot: thence turn an angle of 94 degrees 37 minutes to the right and run along the north line of said Strickland lot 210 feet to the point of beginning.
