On February 22, 1941, Shelby Building and Investment Company, a corporation, deeded to A. W. Vaughan and Harriet S. Vaughan, Lot 2 in Block D of Lyman's Addition to the Town of Montevallo, Alabama, which is recorded in the Probate office of Shelby County, Alabama, in Deed Book 111, page 297. The purchase price for the aforementioned property was \$12,000.00, of which sum we paid \$10,000.00 in cash and the balance of \$2,000.00 was, by agreement, divided into payments of \$250.00 each and were payable as follows:

- Note No. 1 due March 21, 1942 to Frank W. Bulger for \$250.00
- Note No. 2 due March 21, 1942 to Mr. & Mrs. Jerry Ahern for \$250.00
- Note No. 3 due September 21, 1942 to Frank W. Bulger for \$250.00
- Note No. 4 due September 21, 1942, to Mr. & Mrs. Jerry Ahern for \$250.00
- Note No. 5 due March 21, 1943 to Frank W. Bulger for \$250.00
- Note No. 6 due March 21, 1943 to Mr. and Mrs. Jerry Ahern for \$250.00
- Note No. 7 due September 21, 1943, to Frank W. Bulger for \$250.00
- Note No. 8 due September 21, 1943 to Mr. and Mrs. Jerry Ahern for \$250.00

All of said notes were paid and I have in my possession cancelled checks showing the payment thereof. All of the notes were delivered to us as we paid them and I have all the notes in my possession except Note No. 7 which I am unable to find but I know it was paid. Anyway, I hold cancelled check written by A. W. Vaughan payable to Frank W. Bulger showing on its face that Note No. 7 was paid by that check.
