KNOW ALL MEN BY THESE PRESENTS that for and in consideration of the sum of One Dollar in hand paid to the undersigned George L. Martin and Rose J. Martin by Paul Wyatt, J. C. Garrett, and Floyd Knowles as Trustees of Concord Baptist Church, said George L. Martin and Rose J. Martin hereby releases the following property from the operation of that certain mortgage executed by Natt C. Smith and wife, Blanche C. Smith to said George L. Martin and Rose J. Martin, dated October 7, 1955, and recorded in the Probate Office of Shelby County, Alabama, in Mortgage Book 240, page 504, namely:

A portion of the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 33, Township 21 South, Range 2 West, more particularly described as follows: Commence at the Southwest corner of Section 33, Township 21 South, Range 2 West, thence North 89 degrees 15 minutes East 1491.6 feet to the Northwest right of way line of Farm to Market Road No. 22; thence turn an angle to the left of 34 deg. 30 min. and run 350 feet along the Northwest right of way line of said road; thence turn an angle to the left of 87 deg. 37 min. and run 273.3 feet to the point of beginning of the lot herein conveyed; thence turn an angle to the right of 101 degrees and run 478 feet; thence turn an angle to the right of 103 deg. 15 min. and run 165 feet; thence turn an angle to the right of 97 degrees and run 469 feet to the point of beginning, containing .88 acre, more or less. Situated in Shelby County, Alabama.

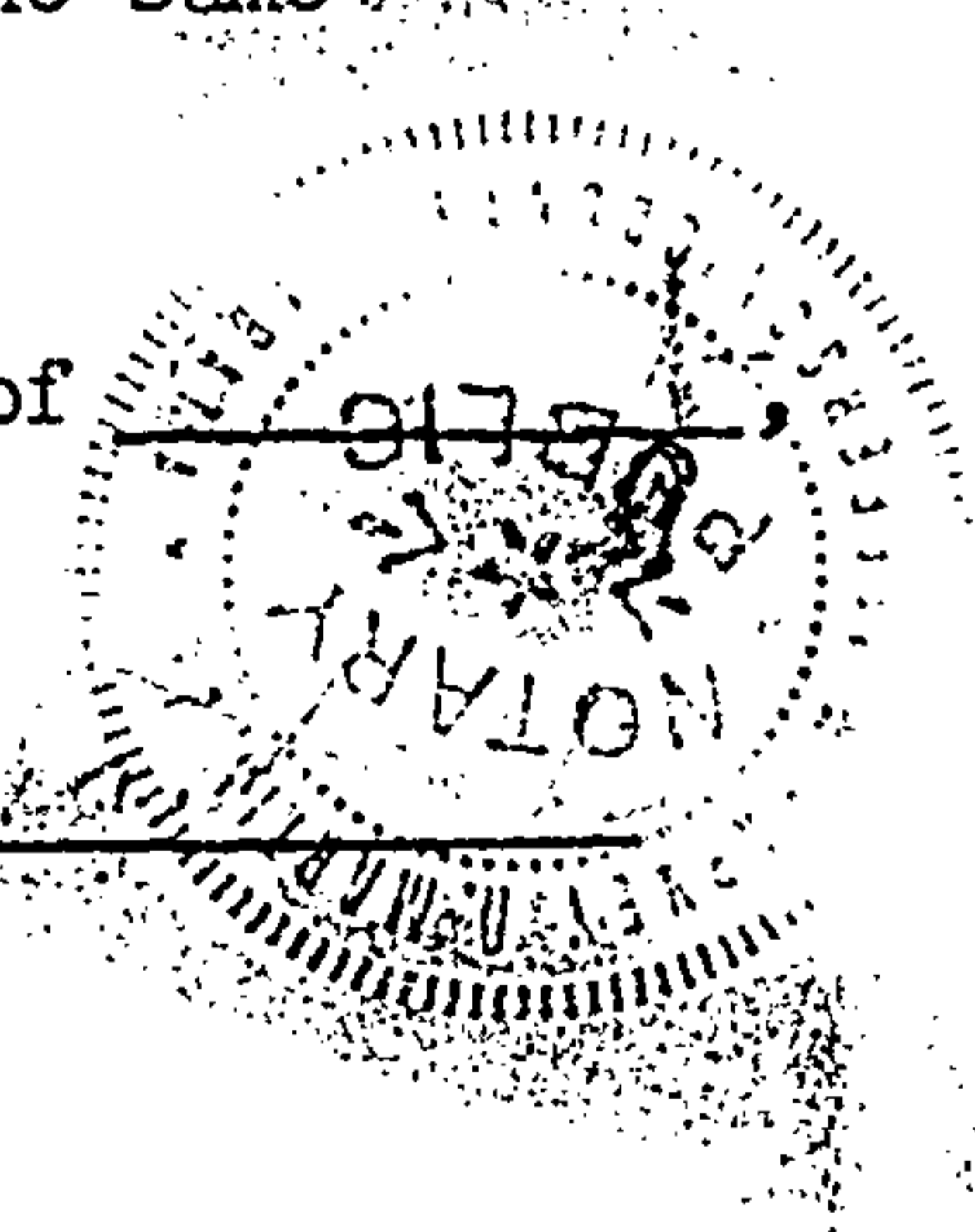
