the receipt whereof is acknowledged we the said B. E. Cunningham and wife,
Nellie Cunningham do grant, bargain, sell and convey unto the said
Hobart Lee.....

the following described real estate situated in Shelby County, Alabama, to-wit:

Begin at the northeast corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 31, Township 20,
Range 2 East and run west along the north boundary of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said
Section a distance of 240.35 feet; thence turn an angle of 153 deg. 32 min. to
the left and run a distance of 263.25 feet to a point on the east boundary of
the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$; thence turn an angle of 117 deg. 50 min. to the left and
run north along the east boundary of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ a distance of 116.25
