

ASSIGNMENT OF MORTGAGE

Farr, in consideration of \$6,000.00, in hand paid by First National Bank of Columbiana, Columbiana, Alabama, do hereby transfer and assign, bargain, sell and convey unto the said First National Bank of Columbiana, Columbiana, Alabama, the note described in the mortgage and all my right, title and interest in said mortgage and in and to the property described, which said mortgage and property are as follows: Mortgage from Jack Eugene Gray and wife, Betty Jo Gray, to E. D. Farr's land; thence in a northerly direction along said branch to the north line of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 23, Township 21, Range 1 West; thence run west along said forty acre line to the east line of said highway; thence along same in a southeasterly direction to the point of beginning; being situated in Shelby County, Alabama.

This Assignment is made in connection with a loan made by the Assignee to the Assignor, with the express understanding that when said loan is paid in accordance with its terms, said Assignee shall reassign the above mentioned mortgage and note to the Assignor herein.
