All that part of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ Section 6, Township 21 South, Range 2 East, Huntsville Meridian, Shelby County, Alabama, lying below the 450 contour; being more particularly described as follows:

Commence at the northeast corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 6, Township 21 South, Range 2 East, having Coordinates of North 993,535.9 feet East 303,822.2 feet, this corner will hereinafter be known as the point of beginning.

Beginning at the point of beginning thence South 00 degrees 35 minutes West 310.4 feet to a point on the 450 contour having Coordinates of North 993,225.5 feet East 303,819.0 feet, thence along the 450 contour in a southwesterly direction to a point, at the intersection of the 450 contour and the south line of Section 6, having Coordinates of North 992,230.8 feet East 303,110.9 feet, thence North 89 degrees 35 minutes West 620.0 feet, thence North 00 degrees 33 minutes East 1323.8 feet, thence South 89 degrees 00 minutes East 1318.6 feet to the point of beginning.
