KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Dollar and the love and respect I have for the First Methodist Church of Vincent, the undersigned Grantor does release remise, quit claim and convey unto L. Raley, as Trustees of the First Methodist Church of Vincent, and their successors in office, subject to the conditions set forth herein, the following described real estate situated in Vincent, Shelby County, Alabama:

One Hundred and Fifteen (115) feet by One Hundred and Twenty-Five (125) feet, on the corner of Fifth (5th) Street and First (1st) Avenue; fronting One Hundred and Fifteen (115) feet on Fifth Street and running back One Hundred and Twenty-Five (125) feet in uniform width of One Hundred Fifteen (115) feet, along First Avenue, all in Block 28 as shown by map and plat made by John A. Edwards and recorded in the Office of the Judge of Probate of Shelby County, Alabama, situated in the West One-half (W $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 11, Township 19, Range 2 East, in the Town of Vincent, Shelby County, Alabama

In trust, that said premises shall be kept and maintained as a place of divine worship of the Methodist ministry and members of the Methodist Church: subject to the Discipline, usage and ministerial appointments of said church as from time to time authorized and declared by the General Conference and by the Annual Conference within whose bounds the said premises are situated. 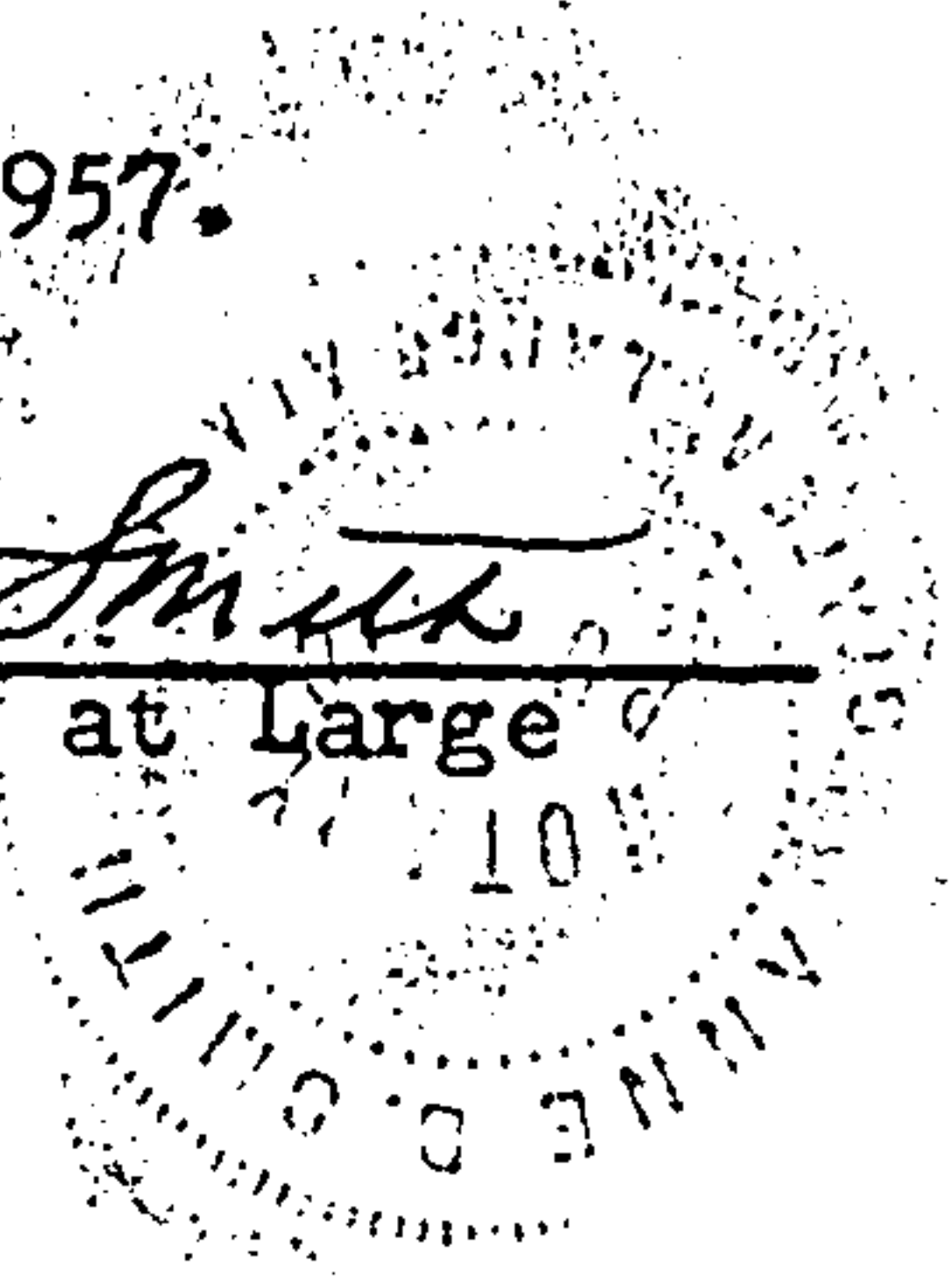
