Commence at the Northwest (NW) corner of Section 6, Township 24 North, Range 13 East, and run East along the North Line of said Section 6 a distance of 1148.25 feet, thence turn an angle of 109 degrees 11 minutes to the right and run a distance of 2218.0 feet, to a point on the South R. O. W. Line of Highway #25 and the point of beginning , thence turn an angle of 68 degrees 10 minutes to the right and run along the South line of Highway #25 a distance of 330.0 feet, thence turn an angle of 61 degrees 17 minutes to the left and run a distance of 525.3 feet to the center line of old Highway, thence turn an angle of 94 degrees 58 minutes to the left and run along the center line of old Highway a distance of 167.0 feet, thence turn an angle of 20 degrees and 09 minutes to the left and continue along the center line of old Highway a distance of 430.4 feet, thence turn an angle of 93 degrees 37

This release shall in no manner affect the said mortgage as to the remainder of the premises described therein and not hereby specifically released or released by other instruments heretofore executed.


