KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, Aubin Knowles and wife, Dorothy Jeanette Knowles executed a certain mortgage to the undersigned Garnette Knowles, on the 16th day of December, 1958, which said mortgage was recorded in Mortgage Book 257, page 395, therefore, the undersigned, Garnette Knowles, in consideration of Five Hundred and no/100 Dollars (\$500.00), in hand paid by the said Aubin Knowles and Dorothy Jeanette Knowles, the receipt whereof is hereby acknowledged, does hereby release, remise and quit claim unto the said Aubin Knowles and Dorothy Jeanette Knowles, all the right, title, and interest acquired under said mortgage in and to that part of the premises conveyed therein, described as follows, to-wit:

Commence at the NW corner of Section 6, Township 24 North, Range 13 East, and run East along the North line of said Section 6 a distance of 1148.25 feet; thence turn an angle of 109 deg. 11' to the right and run a distance of 2218.0' to a point on the South right of way line of Highway 25 and the point of beginning; thence turn an angle of 68 deg. 10' to the right and run along the South line of Highway 25, a distance of 330.0'; thence turn an angle of 61 deg. 17' to the left and run a distance of 525.3' to the center line of old highway; thence turn an angle of 94 deg. 58' to the left and run along the center line of old highway a distance of 167.0'; thence turn an angle of 20 deg. 09' to the left and continue along the center line of old highway, a distance of 430.4'; thence turn an angle of 93 deg. 37' to the left and run a distance of 554.95' to the point of beginning. Situated in Shelby County, Alabama.

TO HAVE AND TO HOLD THE SAME to the said Aubin Knowles and Dorothy Jeanette Knowles, their heirs and assigns forever.

This release shall not in any way impair or effect the right of the said mortgagee to hold the remainder of the premises conveyed in said premises and not hereby released as security for that part of the mortgaged indebtedness remaining unpaid.


