A resolution to assent to the vacation and annulment of that certain street seventy-five (75) feet in width in the Town of Calera, Shelby County, Alabama, which lies between Lots I through 16, of Block 113, and Lots 17 through 32 of Block 114 of the survey of the Town of Calera, Alabama, which said certain street is designated as Sixth Street, the portion herein described being that portion of such street which lies between Ninth Avenue and Tenth Avenue as shown by said survey of the Town of Calera, Shelby County, Alabama.

BE IT RESOLVED by the Town Council of the Town of Calera, Shelby County, Alabama, that:

WHEREAS, it has been made to appear to the Council of the Town of Calera that the said W. G. Nichols and wife, Maude Allison Nichols, and Alabama Power Company, a corporation, are the owners of all the property abutting the foregoing described portions of said Street or Avenue; and

WHEREAS, it appearing that a convenient and reasonable means of ingress and egress to and from their property is afforded to other property owners by the remaining streets dedicated by said survey or by other existing streets;

NOW, THEREFORE, be it resolved by the Town Council of the Town of Calera, Alabama, that the assent of this Council be and the same is hereby given and granted to the vacation and annulment of said portions of said street or avenue of all public rights of easements therein, if the said W. G. Nichols and wife, Maude Allison Nichols, and the said Alabama Power Company, a corporation, as such owners execute an instrument in writing declaring the said portions of said street or avenue as above described to be vacated and annulled, such written instrument to be executed and acknowledged in like manner as a conveyance of land.

BE IT FURTHER RESOLVED that a copy of this resolution properly certified by the Town Clerk of the Town of Calera, be attached to, filed and recorded with the said declaration of vacation and annulment in the office of the Judge of Probate of Shelby County, Alabama, when and if such declaration of vacation and annulment is so executed by the said owners.
