

DECLARATION OF VACATION 550

KNOW ALL MEN BY THESE PRESENTS, that, whereas, the undersigned, Alabama Power Company, a corporation, and W. G. Nichols and wife, Maude Allison Nichols, are the owners of all the property abutting both sides of that portion of that certain street, seventy-five (75) feet in width, in Shelby County, Alabama, which lies between Lots 1 through 16 of Block 113 and Lots 17 through 32 of Block 114 of the survey of the Town of Calera, Alabama, and said certain street is designated as "Sixth Street" and the portion herein described being that portion of such street which lies between Ninth Avenue and Tenth Avenue of said survey.

WHEREAS, the undersigned, Alabama Power Company, a corporation, is joined by W. G. Nichols and wife, Maude Allison Nichols, and are desirous of vacating and annulling such portions of said street so as to destroy the force and effect of any dedication thereof by map, plat or otherwise, and to divert any and all rights of the public, including any rights which may have been acquired by prescription or otherwise, on that portion of said street hereby vacated; and

WHEREAS, convenient and reasonable means of ingress and egress to and from their property is afforded to all other property owners by the remaining streets and alleys dedicated by said map or plat, or by other existing streets or alleys:

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES, and for the purpose of vacating and annulling the above described portions of said street, the undersigned, Alabama Power Company, a corporation, is joined by W. G. Nichols and wife, Maude Allison Nichols, being the owners of all the property abutting both sides of the portion of said street sought to be vacated and annulled, do hereby declare that the above described portions of said street be and the same is hereby vacated and annulled, so as to destroy the force and effect of any dedication thereof by map, plat or otherwise and to divest any and all rights of the public which may have been acquired by prescription or otherwise in that portion of said street are hereby vacated and annulled.
