KNOW ALL MEN BY THESE PRESENTS, That I, Yorlande Degg Hudgins of Birmingham, Jefferson County, Alabama, being of sound and disposing mind, and over the age of twenty-one years, do hereby make and publish this my last will and testament, hereby revoking all former wills at any time heretofore by me made.

FIRST: It is my will that my hereinafter named executors shall pay all of my just debts as soon after my decease as they may consider compatible with the best interests of my estate.

SECOND: I do hereby give and devise to Evelyn Christopher Fallin, the sum of Three Thousand Seven Hundred and Fifty Dollars (\$3,750.00) to be used by her as part payment on a home. I hereby direct that my executors pay over to her the sum of Three Thousand Seven Hundred and Fifty Dollars (\$3,750.00).

THIRD: I do hereby give, devise and bequeath to Jesse Hamilton Hudgins and Joe Della Hudgins, all other properties of which I die seized and possessed, real, personal and mixed, wherever located, in fee simple forever.

FOURTH: I do hereby nominate and appoint Jesse Hamilton Hudgins and Joe Della Hudgins, as the executors of this my last will and testament and do direct that they shall act as such executors without bond and without making any report to any court except such as may be absolutely required by law.

FIFTH: I do hereby order and direct that Jesse Hamilton Hudgins and Joe Della Hudgins, who are executors of this my last will and testament, shall be clothed with the power to dispose of any and all of my property by deed or otherwise, without the necessity of obtaining any orders from any court just as I could dispose of said property were I then living.

IN TESTIMONY WHEREOF, I, the said Yorlande Degg Hudgins, have unto this my last will and testament, set my hand and seal, this the 26 day of September, 1953.


