Hwy. 25 and the point of beginning; thence turn an angle of 5 deg. 42 min. to the left and run along the North R.O.W. line of said Hwy. 25 a distance of 114.0 feet; thence turn an angle of 83 deg. 02 min. to the right and run a distance of 185.50 feet; thence turn an angle of 83 deg. 02 min. to the left and run a distance of 135.10 feet; thence turn an angle of 96 deg. 58 min. to the left and run a distance of 185.50 to a point on the North R.O.W. line of said Hwy. 25; thence turn an angle of 96 deg. 58 min. to the right and run along the North R.O.W. line of said Hwy. 25 a distance of 42.90 feet; thence turn an angle of 83 deg. 02 min. to the right and run a distance of 963.80 to a point on the South R.O.W. line of old Montevallo - Calera Hwy.; thence turn an angle of 120 deg. 10 min. to the right and run along the South line of old Montevallo - Calera Hwy. a distance of 335.45 feet; thence turn an angle of 59 deg. 50 min. to the right and run a distance of 831.15 feet to the point of beginning.

On the balance of said land, said mortgage and lien therein described remain in full force and effect.
