Before me, W. H. Hughes, the undersigned authority in and for said County in said State, personally appeared John W. Moore, who, after being by me first duly sworn to speak the truth, deposes and says:

My name is John W. Moore. I am 79 years of age and have been a resident of Shelby County, Alabama, all of my life.

Affiant further says he was famaliar with Weldon and Company to which certain land in Shelby County, Alabama, was conveyed in January 1897, as shown by deed recorded in Deed Book 35 page 345 in the Probate Office of Shelby County, Alabama. There has been called to affiant's attention a deed from R. G. Weldon, J. E. Adams and M. A. Adams, also known as Mary A. Adams, to Allen Lumber Company, as shown by deed recorded in Deed Book 20 page 359 in said Probate Office. Affiant further says that the said Weldon and Company was a partnership and on November 1, 1897, R. G. Weldon, M. A. Adams and her husband, J. E. Adams, were the sole owners of said partnership.

Affiant further says there has been called to his atten<sup>ion</sup> that D. Corenblum, Nathan Lewis and Abraham Green at one time owned said land. Affiant further says that the land hereinafter described has never constituted the homestead of any of said parties. Said land being described as follows:

That certain parcel of land described as beginning at the intersection of the north and south center line and being the west line of the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 30, with the north right of way line of U.S. Highway 280, known as the Florida Short Route Highway, and run thence north along said north and south center line to the center of the north line of said Section 30, said point being the northwest corner of the NW $\frac{1}{4}$  of NE $\frac{1}{4}$  of said Section 30; run thence east along said north line of said Section 30 for a distance of 330 feet; run thence south and parallel with the north and south center line of said Section 30 to the north line of said north right of way line of said Highway; run thence in a westerly direction along the north right of way line of said Highway to the point of beginning, all of the above described land is situated in Section 30, Township 19, Range 1 East, Shelby County, Alabama.

Affiant further says that he is acquainted with Juston Clyde Walton and Mattie Walton who at one time owned said land. It is called to affiant's attention that said land was assessed to J. C. Walton and affiant knows of his own knowledge that he is one and the same person as Juston Clyde Walton.
