ORDERED, ADJUDGED AND DECREED By the Court:

1. That the complainant, William Arnold, is the owner of the real estate described in the original bill in this cause and which real estate is situated in the County of Shelby, State of Alabama; and more particularly described as follows:

The $W\frac{1}{2}$ of $W\frac{1}{2}$ of $NE\frac{1}{4}$ of Section 9, Township 22, Range 3 West, except that portion of the same sold to Raymond Johnson Sherer by deed recorded in the Probate office of Shelby County, Alabama in Deed Book 179, page 9, such exception being described as follows: Begin at the NW corner of the $NW\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 9, Township 22, Range 3 West; thence South along the Montevallo-Blyton Road 850 ft. to the S/S of the Keeler Mill Road; thence in a SE direction along the southwest margin of said Keeler Mill Road 750 ft; thence North 1230 ft. to the North line of said $NW\frac{1}{4}$ of $NE\frac{1}{4}$; thence West along said North line of said 40 acres 660 ft. to point of beginning.

2. That the respondents, Bertie Harrison, J. D. Lawley, Marvin W. Lawley, Blanch Lovelady, Jessie Woods and Gaston Cruse, in this cause, have no right, title or interest in, or encumbrance upon such lands above described, or any part thereof,

3. That the Register, within thirty days from this date, filed a certified transcript of this decree for record in the Probate Court of Shelby County, Alabama, the County in which said land lies; and that the Probate Judge record and index said decrees as required by Code 1940, Tit. 7, § 1113.

4. That the complainant pay the costs of this suit to be taxed by the Register, for which let execution issue.
