do grant, bargain, sell and convey unto the said Irma Dean Harris Isbell and husband, Noah Isbell

as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

Begin at the northeast corner of the  $SE_4^1$  of the  $NW_4^1$ , Section 16, Township 19, Range 1 West, and run south along the east line of said forty acres a distance of 440 feet to the point of beginning of the lot herein described; thence run south along the east line of said forty acres a distance of 90 feet to the point where said east line of said forty a cres intersects the northwest right of way line of a new road now under construction known as the "New Dunnavant Road"; thence run in a southwesterly direction along the northwest right of way line of said new road a distance of 110 feet to a point; thence run west, parallel with the north line of said forty acres, a distance of 220 feet to a point; thence run in a northeasterly direction a distance of 200 feet to a point which is 220 feet west(on a line parallel with the north line of said forty acres) from the point of beginning; thence run east, parallel with the north line of said forty acres, a distance of 220 feet to the point of beginning.
