THIS LEASE, made this _____ day of June, 1960, by and between Karl Nickerson, Executor of the Estate of Kents Brant Nickerson, Deceased, hereinafter called party of the first part, and Corinthian Lodge No. 462, F. & A. M., party of the second part.

WITNESSETH, that the party of the first part does hereby rent and lease unto party of the second part, the following premises in the Town of Alabaster, Alabama, viz:

Alabama. and being the same lot heretofore conveyed by the party of the first part to the party of the second part. as shown by deed dated August 26, 1956, and recorded in Deed Book 182, on Page 224, in the office of the Judge of Probate of Shelby County, Ala.

for occupation by said Corinthian Lodge No. 462, F.& A.M. as a walk-way, and not otherwise, for and during the term of twenty years, to-wit; from the first day of June, 1960, to the first day of June, 1980, and covenant to keep party of the second part in possession of the premises during said term.

In Consideration Whereof, the party of the second part agrees to pay to the party of the first part One and No/100 (\$1.00) in advance.

It is further agreed, that in the event the party of the second part continues to occupy said premises after the term herein specified, such occupancy shall operate as a renewal of this lease.

It is further agreed that party of the first part may terminate this lease by giving party of the second part thirty days notice of its intention to terminate.
