after being by me first duly sworn to speak the truth, deposes and says:

My name is Alton Young. I am a registered land surveyor No. 1666
and am familiar with the hereinafter described tract of land, viz:

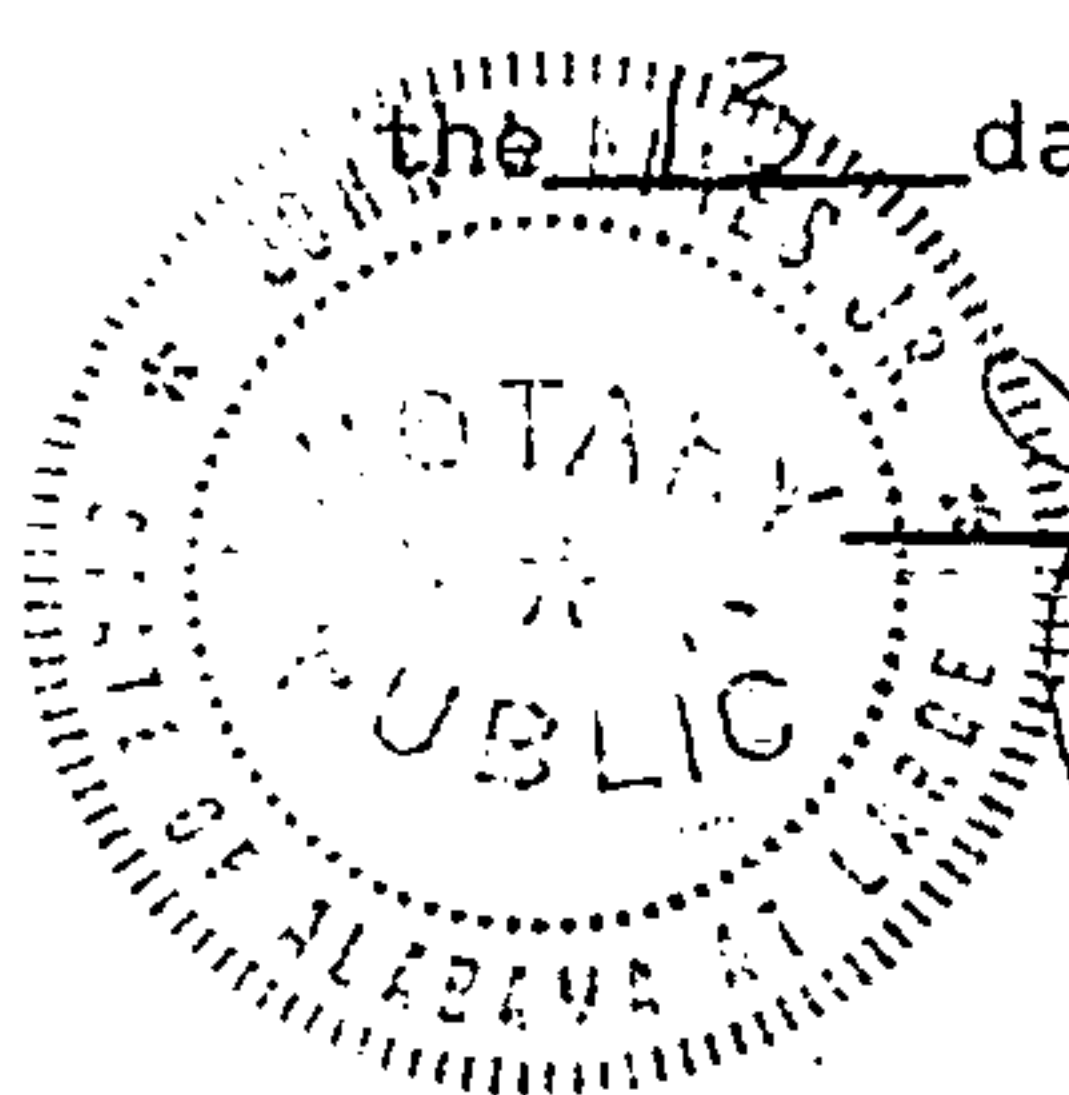
From the southwest corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16,
Township 19 South, Range 2 West, run northeasterly along the
Northeast-Southwest diagonal line of the said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of
Section 16, Township 19 South, Range 2 West for 347.72 feet; thence
turn an angle of 45 deg. 57 min. to the right and run easterly 70.52
feet to the point of beginning of the land herein described; thence
turn an angle of 47 deg. 20 min. to the right and run southeasterly
336.59 feet, more or less, to a point on the north right of way line
of a County paved road; thence turn an angle of 84 deg. 35 min. to
the left and run northeasterly 202.52 feet to a point on the north
right of way line of said road; thence turn an angle of 04 deg.
10 min. to the right and continue northeasterly 227.36 feet to a
point on the north right of way line of said road; thence turn an
angle of 146 deg. 55 min. to the left and run westerly 579.92 feet,
more or less, to the point of beginning; Being a part of the
SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 16, Township 19 South, Range 2 West, and
being 1.60124 acres, more or less, and being situated in Shelby
County, Alabama.

southeast diagonal half
