My name is Frank Fulton. I am 61 years of age and have lived in and around Columbiana, Alabama, all of my life and have all along been familiar with the hereinafter described land; in fact, at one time I owned said property. Said land being described as follows:

Commence at the northeast corner of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 34, Township 21 South, Range 1 West; thence run south, 41 deg. 24 min. west a distance of 679.90 feet to the point of beginning, thence run south a distance of 340.0 feet; thence run west a distance of 200.0 feet; thence run north a distance of 340.0 feet; thence run east a distance of 200.0 feet to the point of beginning; situated in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 34, Township 21 South, Range 1 West, Shelby County, Alabama.

Affiant recalls when his father J. H. Fulton purchased the entire NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 34, in which the above described property is situated, in the year 1917. Affiant says at that time the road which leads from Ala. Highway 25 in a northerly direction just west of Johnny Queen place and just east of Jim Brasher place and continues in a northwesterly direction to the dwelling house situated on the above described land, was open and was an old road at that time. Affiant's father, after he purchased the land, got the County to work the road and it has been worked by the County and has been used as a public road as many years back as affiant can remember. Said road now serves several dwelling houses and affiant says he has never heard of anyone claiming that said road was not a public road.
