Neal Stinson, who is known to me and who being by me first duly sworn, deposes and says on oath, that he is a son of David Stinson who died testate, in Shelby County, Alabama, on December 30, 1922; that the last will and testament of said David Stinson is recorded in Will Record 1, at page 359 in the Probate Office of Shelby County, Alabama; that the Widow of said David Stinson, who was Ida Stinson, and who was Affiant's Mother, died in Shelby County, Alabama, during the later part of November, 1949; that at the time of her said death, she was survived by the following children, viz:

1. Pearl Stinson Glenn, Affiant's Sister, and who is the wife of W.R. Glenn,
2. Alice Stinson Bradley, Affiant's Sister, and who is the wife of Ollie F. Bradley,
3. Theophilus M. Stinson, Affiant's Brother, and who is the husband of Carrie Stinson; said Theophilus M. Stinson was referred to in the Petition to probate the last will and Testament of Affiant's Father, David Stinson, as "Offie" Stinson, the same being a family nick name.
4. W.W. Stinson, Affiant's Brother, sometimes called Willie Stinson, and who is the husband of Elizabeth Stinson.
5. S. Parish Stinson, Affiant's Brother, and who is the husband of Essie Stinson,
6. Sadie Stinson Bolton, sometimes called Sadie M. Bolton, Affiant's Sister, and who is the wife of Dewey F. Bolton,
7. John T. Stinson, Affiant's Brother, who is the husband of Ruby Stinson,
8. Elsie Stinson, Affiant's Sister, the wife of T.H. Hill,
9. Affiant, whose wife is named Bertie Lee Stinson.

Affiant further says that Affiant's Sister, Edna Stinson Hill, the first wife of T.H. Hill, predeceased Affiant's Mother, Ida Stinson, in Shelby County, Alabama; said Edna Stinson Hill, died on July 8, 1924; that she was survived by her husband T.H. Hill, and by the following children, viz:

1. Stinson Hill, the husband of Mary E. Hill,
2. Harold Hill, the husband of Dot Hill,
3. Elsie Faye Clark, the wife of Dewey Clark,
4. William Arthur Hill, single.

Affiant further says that Stinson Hill, Harold Hill and William Arthur Hill are all Nephews respectively of Affiant, and Elsie Faye Clark is a Niece of Affiant; that said children are all of the children born of the marriage of Affiant's Sister Edna Stinson and T.H. Hill; that as such they are the sole heirs at law of their Mother, Edna Stinson Hill; that sometime after the death of said Edna Stinson Hill, and while the children were small, Affiant's Sister Elsie Stinson married to the said T.H.
