Before me the undersigned Authority appeared Mary Emily Collins, who being duly sworn deposes and states as follows:

That AFFIANT is 79 yrs. of age, and is a resident citizen of Shelby County, Alabama, living at Box 153 Route 1, Helena, Ala., which is at the Fork of the Cahaba Valley Road and old Caldwell Mill Road, said property being in the W $\frac{1}{2}$ of the SE $\frac{1}{4}$ Section 22, Township 19, Range 2, West. This property lies West of Bishop Creek, also known as Cahaba Valley Creek, North of the Cahaba Valley Road, and East of old Caldwell Mill Road.

That AFFIANT's husband had the house built on the above property over 30 years ago, and AFFIANT's brother built the house.

That after the house was built, AFFIANT and her husband moved into the house, and AFFIANT has lived in the house continuously since that time.

That AFFIANT's Father-in-law Richard (Dick) Collins and AFFIANT's husband bought the above property and other property in 1909 from a Mr. Gilbert who had a Gin on the ^{above} property on the West bank of the creek when it was bought in 1909. Said Gin was there in 1907 when AFFIANT first ~~was~~ knew the above described property.

That after the house above referred to was built, AFFIANT's husband built a store just west of the above referred to house and operated the store until AFFIANT's husband's death on Dec. 11, 1956

That to AFFiant's knowledge no one has been in possession of the property herein described except AFFiant & her husband AND her Father-in-Law, Uncle Dick Collins, since 1907, and that AFFiant's husband had a "patch" on the property from the time he bought it until he had the home built.

That AFFiant knows that no one from the Church which lies ~~west~~ East of the creek has ever claimed to own any of the property west of the creek, and AFFiant remembers well a conversation with Uncle Billy Gilbert many years ago when Uncle Billy pointed out where the boundaries were of the Two (2) acres which belonged to the Church for church and school purposes; That all of this two acres was pointed out as being East of the creek, and North of the Cahaba Valley Road. That at that time the Cahaba Valley Road was further South than it is now, but the creek is in the same place. Further AFFiant deposeseth not.
