located for the purpose to ingress and egress.

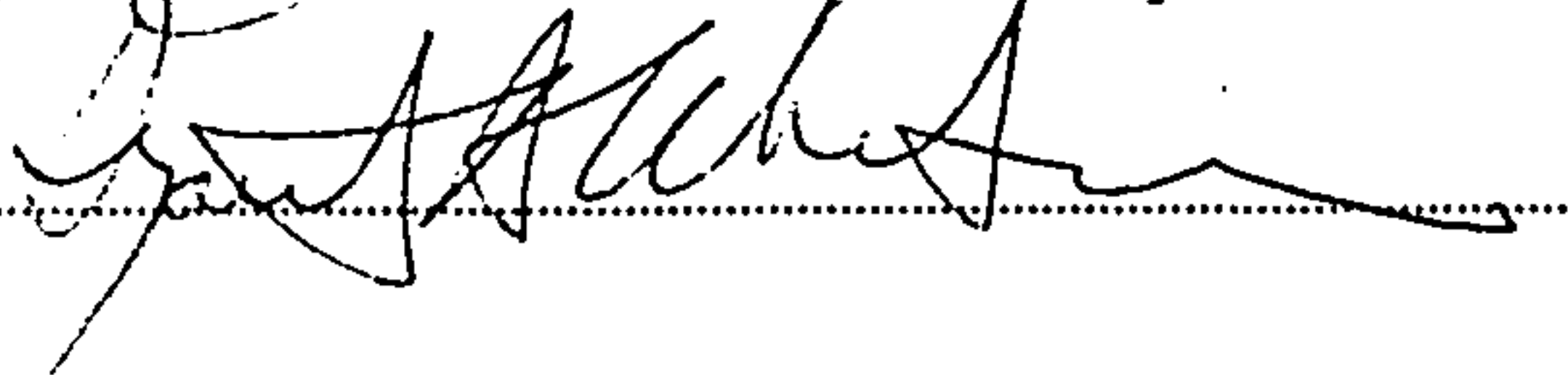

used as a burial ground title shall revert to grantors.

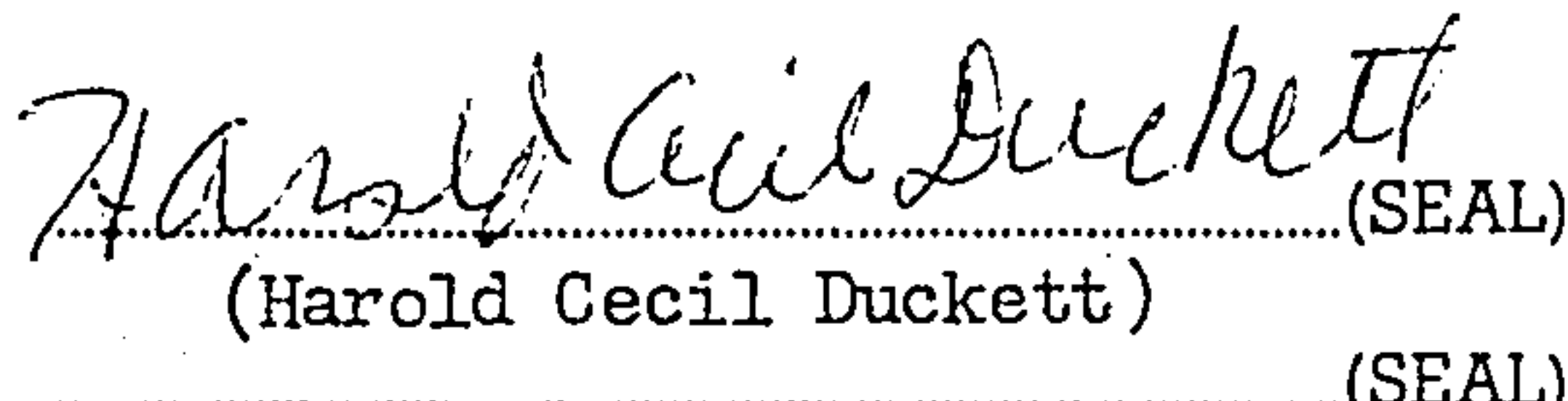

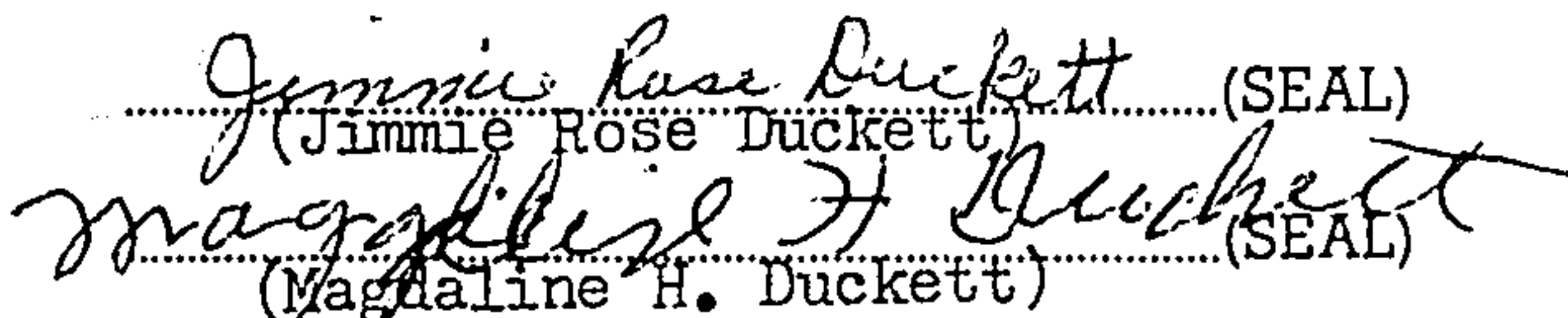
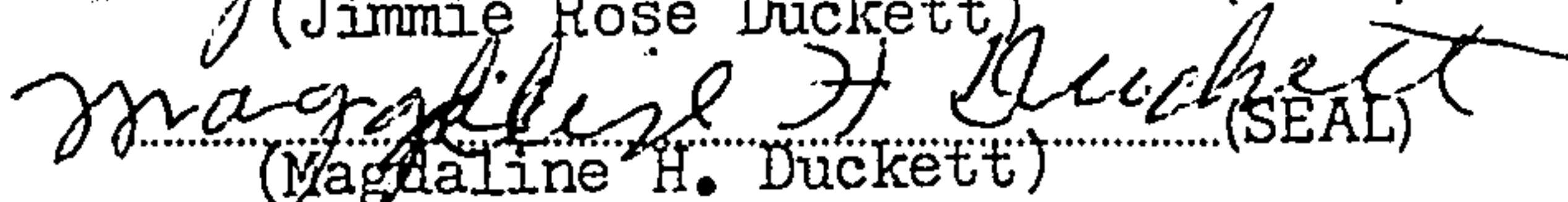
