The same being a part of the premises conveyed by Theo Kuffner to said P. J. Kroell by deed dated 11th day of June 1918, and which is recorded in deed Book 64 page 174-176 in the office of the Probate Judge of Shelby County, Alabama. The above described property being the same property conveyed to A. E. West 215.1 feet to an iron pin; thence North 33 deg. 15 min. East 50.0 feet to an iron pin; thence North 56 deg. 45 min. West 30.0 feet to an iron pin; thence North 33 deg. 15 min. East 443.07 feet to the point of beginning; thence North 33 deg. 15 min. East 70.6 feet to an iron pin; thence South 56 deg. 45 min. East 91.7 feet to an iron pin; thence South 22 deg. 00 min. West 73.5 feet; thence North 57 deg. 22 min. West 122.54 feet more or less to the point of beginning.
