WITNESSETH: That the said party of the first part, for and in consideration of the sum of One Dollar, and other good and valuable consideration, in hand paid to them by the party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained and sold and by these presents do grant, bargain, sell and convey unto the said A. R. Woolley, the party of the second part, the following described lands, situated, lying and being in

Shelby County, in the State of Alabama, to-wit:

PARCEL ONE: Begin at the SE corner of NW $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 9, Township 24 North, Range 12 East and run thence Northerly along the East boundary of said Quarter Quarter Section to the NE corner of the same; thence Westerly along the North boundary of said Quarter Quarter Section to its intersection with the East boundary of the old Selma dirt road; thence Southerly along the East boundary of said Old Selma dirt road to its intersection with the East boundary of the old Montgomery Dirt road; thence continue Southerly along the East boundary of said Old Montgomery dirt road to its intersection with the South boundary of said Quarter Quarter Section; thence Easterly along the South boundary of said Quarter Quarter Section to point of beginning.
