And Montevallo Development Company covenants and agrees with the said.....

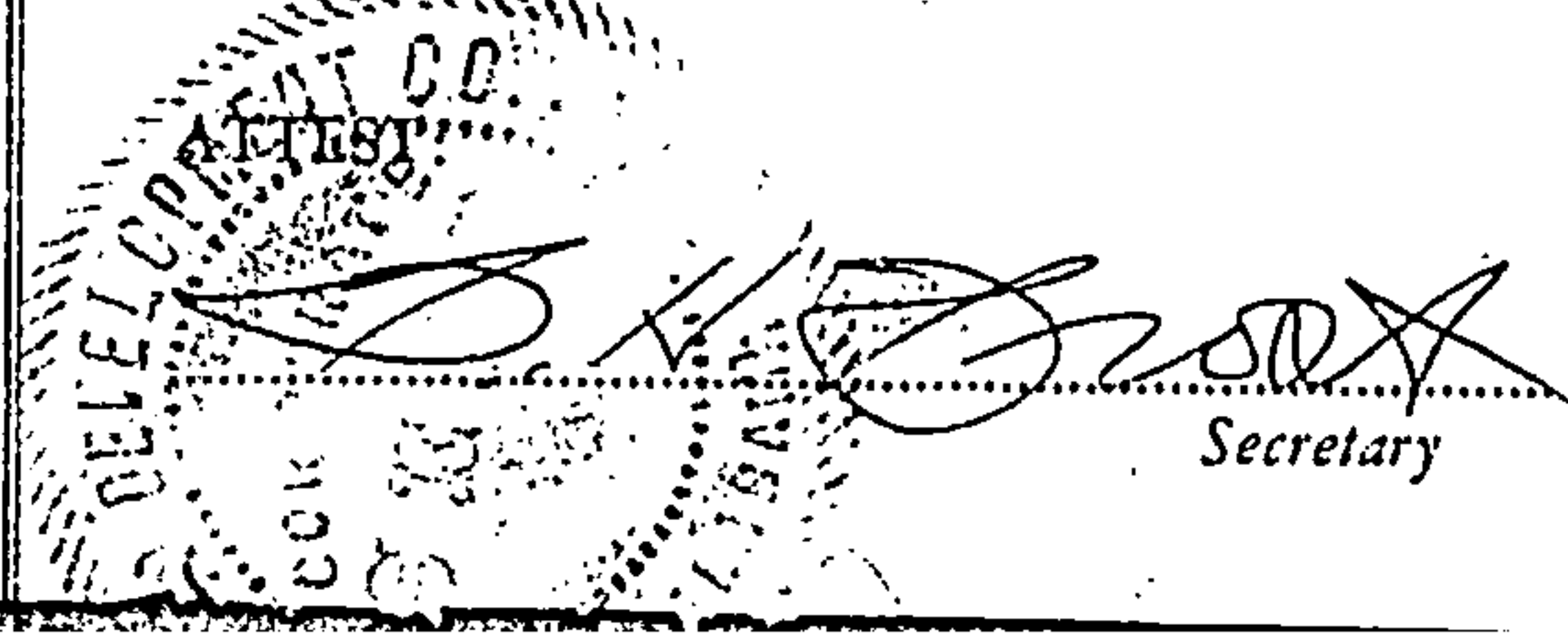

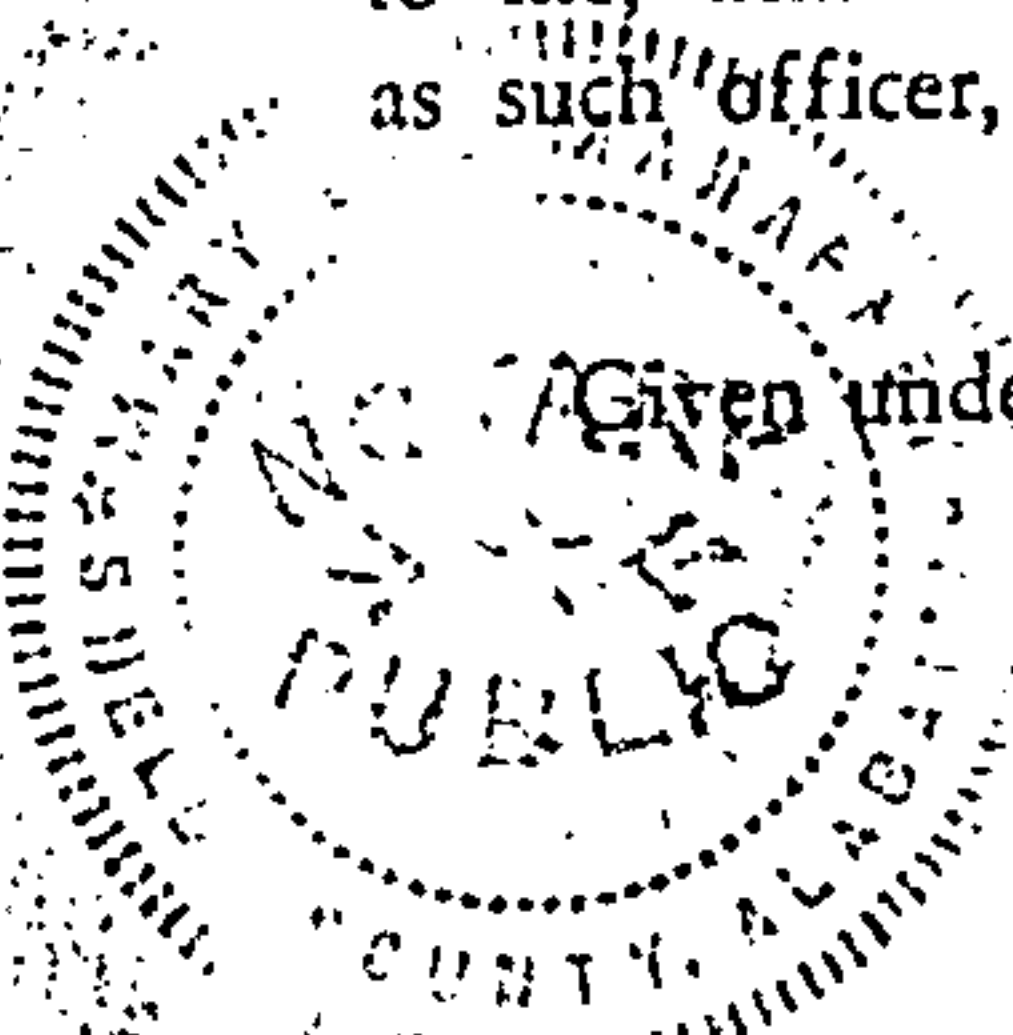
